

PRIVACY POLICY FOR LEAFROW MOBILE APPLICATIONS

Last updated: November 1, 2022

This Privacy Policy governs your use of the Leafrow software application (“Application”) for mobile devices created by Alisa Avdeeva ((teralice125@gmail.com)). The application allows you to create nested lists of any subject. You will be able to create OFFLINE lists without Internet access. In ONLINE mode, there are functions for sharing the list for reading or editing.

What information does the Application obtain and how is it used?

User-Provided Information

The application receives the information you provide when registering with the application. Registration with us is required and done anonymously.

When you register with us and use the Application, you usually provide (a) nickname, and password; (b) transaction information, for example, when you make purchases, respond to any offers, or download or use applications from us; (c) the information you provide to us when you contact us for help; (d) the information you enter into our system when using the Application.

We may use the information you provide to contact you from time to time to provide you with important information, required notices, and promotions.

Automatically Collected Information

In addition, the Application may collect certain information automatically, including, but not limited to, the type of mobile device you use, your mobile device's unique device ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browsers you use, and information about the way you use the Application.

The information that the Application collects is used for providing and improving the Product.

Does the Application collect precise real-time location information of the device?

The application does not track and does not collect accurate information about the location of your mobile device.

Do third parties see and/or have access to information obtained by the Application?

Only aggregated non-personal data may be shared with external services from time to time to help us improve the Application and our service. We will not share your information with third parties without your consent, except as required by law, such as to comply with a subpoena or similar legal process.

How Can I Refuse?

You can stop all collection of information by uninstalling the Application or deleting an account in the Application. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network. You can send an email to tionplanet@gmail.com.

Data Retention Policy, Managing Your Information

We will retain User Provided data for as long as you use the Application and for a reasonable time thereafter. We will retain Automatically Collected information for up to 24 months and thereafter may store it in aggregate. If you'd like us to delete User Provided Data that you have provided via the Application, please contact us at tionplanet@gmail.com and we will respond in a reasonable time. Please note that some or all of the User Provided Data may be required in order for the Application to function properly.

Children

We do not knowingly collect personally identifiable information from children under the age of 6. If a parent or guardian becomes aware that his or her child has provided us with information without their consent, he or she should contact us at tionplanet@gmail.com. We will delete such information from our files within a reasonable time.

Security

We are concerned about safeguarding the confidentiality of your information. We provide physical, electronic, and procedural safeguards to protect the information we process and maintain. For example, we limit access to this information to authorized employees and contractors who need to know that information in order to operate, develop or improve our Application. Please be aware that, although we endeavor to provide reasonable security for the information we process and maintain, no security system can prevent all potential security breaches.
